It teaches about dispute settlement from a holistic perspective and covers all its aspects, both private and public. It is global in terms of format and faculty. The professors are some of the most prominent experts in each field of international dispute settlement and come from the USA, South America, Asia, Africa and throughout Europe. Its structure combines the multicultural approach to legal studies in Continental Europe with the interactive teaching method of the United States and the small-group tutorial system of Oxford and Cambridge. Class size is kept relatively small (35-40 students) to ensure maximum interaction between faculty and students.

How to apply for the Epaminondas Lambadarios MIDS Scholarship

Students who have been accepted to the MIDS program (have received the admission letter) and have applied for financial aid are eligible to participate in the selection for this grant. Their files will be transmitted to the Epaminondas Lambadarios Scholarship Committee.

The Committee is comprised by leading academics and professionals of the arbitration and private international law community in Greece. The Committee is chaired by Dr. Anastasios Gourgourinis, lecturer of Public International Law at Athens University and its members are Mr. Alexander Fessas, Secretary General of the ICC International Court of Arbitration, Dr. Alexander Metallinos, partner at Karatza and Partners law firm in Athens and Dr. George Panopoulos, partner at Lambadarios law firm in Athens.

The Committee will select one student for the Epaminondas Lambadarios Scholarship which will cover part the selected student's tuition and living expenses in Geneva for one year in Geneva.
